



NRMA Insurance Try for the Better PROMOTION Conditions of Entry

1. By entering this **Promotion**, Entrants agree to be bound by these **Conditions**.
2. The **Promoter** is Insurance Australia Limited ABN 11 000 016 722 trading as NRMA Insurance of 189 Grey Street, South Bank, Queensland.
3. The **Promotion Period** commences at 4.00pm AEST on Wednesday 16th March 2016 and closes at 11.59pm AEST on Sunday 4th September 2016.
4. An **Entrant** is any Australian resident that successfully completes an Entry. Employees of the Promoter and their immediate families, related companies of the Promoter and agencies associated with this Promotion are ineligible to be Entrants.
5. To complete an **Entry**, Entrants must accurately complete the requested information in the entry form available at www.NRMAtryforthebetter.com.au and submit so that it is received between the Opening Time and Closing Time for the relevant Prize Draw.
